ACCOUNT AGREEMENT

EXTENSION OF CREDIT BY PRECISION GRAPHICS CENTERS TO APPLICANT SHALL BE SUBJECT TO AND IN CONSIDERATION OF THE FOLLOWING TERM AND CONDITIONS.

APPLICANT AGREES AS FOLLOWS:

- 1) Payment is due thirty (30) days from invoice date.
- 2) Precision Graphics Centers retains the right to charge interest on past due invoices at the rate of eighteen percent (18%) per annum, or at the otherwise highest legal rate of interest.
- 3) In the event of a default, Applicant agrees to pay all costs associated with the collection of monies due on the account, including, but not limited to, attorney's fees and costs of court.
- 4) Applicant agrees that all legal disputes or lawsuits which arise out of this Credit Agreement and Account Agreement, and all collection suits required to be filed against Applicant, shall be filed in Harris County, Texas, being the place of performance of Applicant's obligations.
- 5) Applicant agrees to notify Precision Graphics Centers by certified mail of any changes of ownership, address, or in the form of the entity.
